10.0 Term 2 Week 14

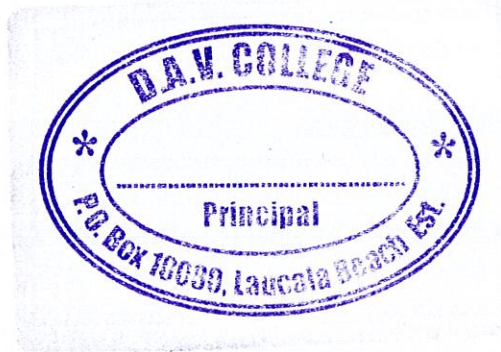
Friday (25/08/23) is the last day of Term 2 and it will be a sports day for School. Assistant Principal will be overall in-charge of the programmes for this sports day.
